- Lighting bids were collected and accepted.

- Chief requested approval to budget \$250 for the January Fire Chiefs' dinner. Parsons made the motion which was supported by Harns to approve budget.

- Parsons submitted an email from Rosemarie Clark concerning county taxes. Parsons will respond.
- Parsons submitted a letter to Supervisor Elliott announcing her resignation from her clerk
 position effective June 30, 2019. Parsons stated that she has been honored to work with board
 and represent the township for the last 17 years.
 - Harns reluctantly made the motion which was supported by Braman to accept Parsons' resignation. All in favor.

Parsons will post the position on Facebook and website the first of January, requesting letters of interest and resumes to be submitted by mid-January so that interviews can occur at meeting. Person will be applying for the clerk's position but will be appointed as a deputy in the months prior in order to learn the election portion of the position and take the necessary classes to become certified as an election coordinator.

Old Business:

Ground Water Testing

Harns made the motion which was supported by Braman to not allow township properties to participate in the testing but Clerk Parsons will notify the owners of the land which was previously tested to get approval for testing. All in favor.

New Business:

• Speck stated that the computer server that the township uses is 10 years old and no longer able to handle all of the data the township is requiring it to store. IT Right has worked with it to condense and remove applications that are not used but it is still in need of an update. Speck made the motion to upgrade to a new, larger server at the cost of \$4708.10 to ensure the safety of township data. Braman seconded motion.
