### Fire Chief:

• Monthly & Year End Reports submitted. 335 Runs in 2018.

- Visited Spartan Motor 1/16/19, new truck is estimated to be here end of Feb. beginning of March.
- AVI equipment has arrived all but Helmets & Vests.
- Lighting for the flag pole will be completed when ground thaws.
- Wetland Gear DNR grant was granted. Fire Dept portion is \$4999
- Applied for Enbridge equipment grant, awaiting decision.
- We were contacted by a teacher wanting I.T.F.D. to participate in "Touch a Truck" for disabled children end of the school year field trip on June 11, 2019 at Hawk Island Park in Lansing.
- Ingham County Chiefs' meeting was held at our station January 17<sup>th</sup>. County Chief's association received a \$45,136.13 grant and is looking at class/training opportunities and brining in guest speakers for these classes.
  - o Sierra Rose Farms contacted I.T.F.D. offering Horse Therapy to our members.
  - o Enforcing Mi OSHA part 451, respiratory protection. This is a state requirement. Chief Speck is working on updating our policy but part 451 has been enforced.
- SOP's Fire Officer Board approved new Apparatus Response #313 & Fire Dept. Secretary job description #121.
  - o Braman made the motion which was supported by Harns to approve SOP #313 & #121 as submitted. All in favor.
- Fire Officer Board approved the purchase of two (2) axes for the new truck up to a total of \$1,000.00. Harns made a motion which was supported by Braman to purchase the axes up to \$1,000.
